

**City of Red Deer**  
**Land and Economic Development**  
**Contest Official Rules**

**Eligibility**

1. The City of Red Deer, Land and Economic Development “Capstone Frame contest and Coffee promotion” Contest is open only to Canadian residents who are over the age of majority in their province/territory of residence at the time of entry. The City of Red Deer Managers, Directors, Councilors and Land & Economic Development staff (“Sponsor”) are not eligible to enter the Capstone Frame contest. Void where prohibited by law.

**HOW TO ENTER**

1. These official rules ("Contest Rules") apply to the “Capstone Frame contest and Coffee promotion” contest (referred to herein as the “Contest”).
2. The City of Red Deer, Land and Economic Development, sponsors the Contest.
3. To enter the Contest, Individuals must submit photo entries before 11:59:59 PM MT on the last day of the contest. **Contest begins April 17, 2021 and ends on April 18, 2021. Draw will take place within 24 hours of the promotion closing.**
4. There is one method through which Eligible Entrants may enter the Capstone Frame photo contest, which is to complete and submit photos by tagging @liveincapstone and Be #CapstoneCurious.
5. One Entry per photo submitted - individuals may enter the Contest more than once.
6. The City of Red Deer is not responsible for lost, misdirected or delayed entries. The City will reject entries received via facsimile, telephone, courier, email, or other method not expressly permitted herein.
7. No purchase is necessary to enter the photo contest, or to receive a complimentary coffee.
8. Must be 18 or older to enter the Capstone Frame contest.
9. One coffee per person, 8 oz, no substitutions or upgrades, must accept as is, during business hours at Dose (Riverside location only) or Meeting Waters, in Capstone, Red Deer.

## **PRIZES AND WINNER SELECTION**

5. There is one (1) prize of “Capstone Gift Basket”. Approximate retail value of Two Hundred Dollars (\$200.00)

6. Prize must be accepted as awarded. The Prizes may not be sold or transferred, and are not convertible to cash. The City of Red Deer, Land and Economic Development, reserves the right to substitute the Prize in whole or in part in the event that the Prize is unavailable. Prize baskets will not be couriered or shipped, and must be picked up in Red Deer.

7. A random draw for the Prize will take place at City of Red Deer, Land and Economic Development offices at The City of Red Deer, #1, 5000 51 St, Red Deer, AB from among all Eligible Entries received during the Contest Period.

The odds of winning the Prize will depend upon the total number of Eligible Entries received. The City of Red Deer, acting reasonably, will attempt to contact the potential winner by social media within two (2) business days after the draw. In the event a potential winner cannot be contacted within two (2) business days after the draw, he or she will be disqualified and an alternate potential winner will be drawn. Proof of identification must be provided upon request. In order to be declared a winner, a potential winner must first correctly answer, unaided, a time limited mathematical skill testing question administered by The City of Red Deer.

## **RELEASE AND INDEMNITY**

8. Before being awarded a Prize, each potential winner may be required to execute and return, within the time stipulated by the City of Red Deer, Land and Economic Development, a release, indemnity and consent form stating that the potential winner has read and understood these Contest Rules, is eligible to receive the Prize under these Contest Rules, accepts the Prize as offered, consents to the public disclosure of the name and municipality of residence in conjunction with the identification of Contest Prize winners, and releases and indemnifies the City of Red Deer, Land and Economic Development from any and all liability arising out of the potential winner's participation in this Contest and receipt and use of the Prize.

## **COMPLIANCE WITH CONTEST RULES**

9. In the event that a potential winner does not comply with all the provisions as contemplated in these Contest Rules, The City of Red Deer, Land and Economic Development, may disqualify the potential winner and may draw an alternate potential winner, and The City of Red Deer, Land and Economic Development, shall be fully and completely released and discharged from any liability or responsibility in this regard. The provisions and procedures referred to above relating to the selection and notification of a potential winner, if applicable, shall be applied, with all necessary amendments, until a qualified winner has been duly selected.

10. By entering this Contest, all entrants and participants agree to accept and abide by these Contest Rules. All decisions of The City of Red Deer with respect to any aspect of this Contest, including without limitation the eligibility of entries, are final and binding on all entrants in all matters as they relate to this Contest.

## **LIABILITY**

11. All entries become property of The City of Red Deer, Land and Economic Development, which assumes no responsibility for garbled, lost, late, or delayed entries, or any computer errors or malfunctions. The City of Red Deer, Land and Economic Development, will not communicate with entrants or potential entrants, except to provide Contest Rules by mail or names of Prize winners (for which a self-addressed, postage paid envelope must be included).

12. The City of Red Deer, Land and Economic Development, does not assume any responsibility for incorrect or inaccurate capture of entry information, technical malfunctions, human or technical error, seeding or printing errors, lost, delayed or garbled data or transmissions, omission, interruption, deletion, defect or failures of any telephone or computer line or network, computer equipment, software or any combination thereof. Entry materials-data that have been tampered with or altered are void. If, for any reason, in the opinion of The City of Red Deer, Land and Economic Development, in its sole discretion, this Contest is not capable of running as originally planned, or if the administration, security, fairness, integrity or the proper conduct of this Contest is corrupted or adversely affected, including by reason of infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures or any other causes beyond its control, The City of Red Deer, Land and Economic Development reserves the right to cancel, terminate, modify, amend, extend or suspend this Contest including canceling any method of entry, and select a winner from previously received Eligible Entries.

## **RIGHT TO MODIFY OR CANCEL CONTEST**

13. The City of Red Deer, Land and Economic Development, reserves the right to modify these Contest Rules without materially affecting the terms and conditions hereof. The City of Red Deer, Land and Economic Development, reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of this Contest or to be acting in violation of these Contest Rules or otherwise in a disruptive manner. The City of Red Deer, Land and Economic Development, reserves the right in its sole discretion to right to terminate the on-line portion, as applicable, of this Contest and conduct the drawing from all on-line entries and all other entries (as applicable) previously received during the Contest Period. Any attempts to deliberately damage the Contest web site or to undermine the legitimate operation of this Contest may be a violation of criminal and civil laws, and, should such an attempt be made, The City of Red Deer, Land and Economic Development, reserves the right in its sole discretion to seek remedies and damages to the fullest extent of the law. The City of Red Deer, Land and Economic Development, shall not be held responsible for any errors or negligence that may arise or occur in connection with this Contest including any damage to an entrant's computer equipment, system, software or any combination thereof, as a result of their participation in this Contest or from downloading any material from the Contest web site, where applicable.

## **APPLICABLE LAW AND PROTECTION OF PRIVACY**

14. This Contest is subject to all applicable federal, provincial and municipal laws and regulations. The Contest is void where prohibited by law. By entering this Contest, each entrant consents to the

collection, use and distribution of his or her personal information (information that identifies an entrant as an individual, such as home telephone number, age and home address) by The City of Red Deer, Land and Economic Development, for the sole purpose of implementing, administering and fulfilling this Contest. The City of Red Deer, Land and Economic Development, will not sell or transmit this information to third parties. 17. This Contest shall be governed by the laws in force in the Province of Alberta. By entering this Contest, all entrants submit to the exclusive jurisdiction of the Courts of the Province of Alberta.

18. The headers provided in the Contest Rules do not form part of the Contest Rules and are only for the purpose of convenience.
